**Minutes of Payhembury Parish Council Meeting held on Wednesday 14th November 2018
at 7.30pm in the Parish Hall**

1. Apologies for absence: Cllr Lorimer, PC Darren England
2. Present: Cllr Williams, Cllr Leach, Cllr Cox, Cllr Eaton, Cllr Ingleson, Cllr Disney
3. Matters agreed: since 12th September 2018, Parish Council approved submission of the Neighbourhood Plan on September 19th.

5. Public session: A Parishioner has noticed a possible omission of a name from the War Memorial, **new Clerk will investigate and report back**. A Parishioner mentioned that no Cllr attended the Health Care Forum in OSM, it was explained that the relevant Cllr was unavailable for that meeting. 11. Transparency Code Grant: The website will go live in the next couple of weeks. **Cllr Williams to email Kev Wooff to find out how the Parish Hall internet is progressing.**
12. Village Parking Update: The request for line painting will go to the HATOC meeting in January 2019.
13. Footpath: S106 funds remain inaccessible, Clerk and Cllr Williams have emailed S Tulack and cc Cllr Skinner without response, now hoping for a retrospective application. Parishioners have donated money and pledged time, cakes, machinery etc. Council remains hopeful that this project can be completed during autumn/winter 2018/19. **Cllr Leach to check insurance requirements for the footpath.** Dog bins and signage both need to be considered. It is planned to open the footpath with a walk possibly to coincide with Parish Council in March. **Clerk to put on January 2019 agenda.** Cllrs thanked Rob Leach for everything that he is doing towards this project.
14. Annual Meeting: Planned to be held on March 23rd was discussed but the Bulb Show is this date, either 16th or 30th March is more likely.
15. Grants and Projects for 2019: It was agreed to award small grants of £50 each to the Tale Valley Trust, Ottery Help Scheme, Parochial Church Council and the Tea and Bingo Club. **Clerk to contact Parish Paper to invite applications from other organisations in need.**

The main projects for next year will be the completion of the footpath, including signage and dog bins. Also, the playing field requires attention, it is hoped to improve the football pitch and provide equipment for teen play, S106 funds should be available for this. Council will need EDDC to engage and will need permission from the church once plans are finalised.

16. Youth Social Update: Cllr Ingleson organised a very successful Halloween themed evening with the help of The Six Bells, approximately 40 children attended.

The idea of recruiting a Youth Parish Cllr was forwarded. **Clerk to draft something for the Parish Paper to attract interest.**

17. Parish Issues: Route maps, Parish Council Assets: Some local flooding was reported, between Crowthers Cross and Yellingham Farm and at Milton near the fishponds entrance. **Cllr Disney to investigate and provide an estimate for clearing any blocked ditches. Clerk to explore the differences between Parishes Together and Communities Together with a view to securing funds for ditch clearance.**
18. Payhembury Sign: On hold for the winter, **Clerk to put back on agenda for January 2019.**
19. Safety mirror on A373: **Cllr Disney will supply the mirror, Cllr Eaton will assist with the positioning.**
20. Neighbourhood Plan: Submitted 19th September 2018, now in the consultation stage.
